

Facilitator Internship

This internship is undertaken to obtain *Facilitator* status in Ellen Tadd's *Framework for Wise Education*. The *Facilitator Internship* is the 3rd level of training in *Framework* certification. One must be a *Framework Practitioner* to enroll in the Facilitator Internship.

This Internship provides a deeper understanding of *Framework* principles through firsthand experience implementing the *Framework* with children and the adults who work with them. There are two parts to this internship. 1) Hands-on experience where one applies the *Framework* in a child-centric environment and 2) teacher training, assisting in teaching the course in Creative Lives program. Knowing the environments in which one works with and cares for children differ, we offer this internship in a two-track model.

- **Track A-Groups:** Is geared toward teachers and those who work primarily, if not exclusively, with children in group settings, such as classrooms, sports teams, and youth groups.
- **Track B-Individuals:** Is geared toward those who work primarily with children one-onone, such as social workers, child psychologists, and parents.

Interns in both tracks also undertake teacher training. During this component of the internship, they assist in teaching no less than:

- **3** One-off workshops.
- 3 Sections of Foundations-1
- 3 Sections of Foundations-2

The final step in attaining *Facilitator* status is an oral presentation to the Creative Lives Assessment Committee, which then votes on awarding *Facilitator* status. If granted, *Framework Facilitator* status permits one to lead Framework Certificate Trainings for Creative Lives Inc., its affiliates, or independently with the express written permission of Ellen Tadd and all agreements pertaining to said authorization.
